What are cookies?

A cookie is a small amount of text stored in your browser (such as Google Chrome or Apple Safari) when you browse most websites.

What kind of information does a cookie store?

The data stored are technical, statistical, concern personal preferences, contents personalisation, etc. Cookies do not usually store sensitive information about the user, such as credit cards or bank details, photographs or personal information, etc. unless expressly indicated.

The web server does not identify the user as an individual, but rather identifies his or her web browser. In fact, if you regularly browse with the Chrome browser and try browsing the same website with the Firefox browser, you will see that the website will not identify you individually because it is actually associating the information to the browser, not the person.

What kind of cookies are there?

- **Technical cookies**: They are the most elementary cookies and, inter alia, allow us to know when a human or an automated computer program (bot) is browsing, when an anonymous user or a registered user is browsing, or the basic tasks for the operation of any dynamic website.
- Analysis cookies: They collect information on the type of browsing being performed, the sections you use the most, the products consulted, the time zone of use, the language, and so on. They are especially relevant for setting up user profiles and for tools such as Google Analytics.

What are own and third party cookies?

Own cookies are those generated by the page you are visiting and those of third parties are those generated by external services or providers.

What cookies does the LDAC website use?

The LDAC website uses its own and third-party cookies. The following cookies are used on this website and are detailed below:

OWN COOKIES:

<u>Preferences</u>: Cookies allow you to remember your settings and preferences to optimise your use of the website, such as your preferred language and privacy settings.

THIRD-PARTY COOKIES

This website uses the following analysis services:

- Google Analytics to help the website analyse the use made by users of the website and improve its usability, but in no case associated with data that could identify the user. Google Analytics is a web analytics service provided by Google, Inc.
- The user may click here to check the type of cookies used by Google.

The LDAC website is built on the Joomla supply platform, which has a cookies policy whose uses can be found in its privacy policy section <u>https://www.joomla.org/privacy-policy.html</u>

Joomla creates a cookie to track user preferences, such as selected language and login status.

As an Internet user, you may at any time proceed to delete the information regarding your browsing habits, and the related profile, by accessing the following link directly and free of charge: https://www.google.com/settings/ads/preferences?hl=es

If a user disables this feature, DoubleClick's unique cookie ID in the user's browser is overwritten with the "OPT_OUT" phase. Because there is no longer a unique cookie ID, the disabled cookie cannot be associated with a specific browser.

Yes, and they can also be blocked, in a general or particular way for a specific domain.
