




"All 50 actions are successfully being implemented. Some already delivered, while work will continue on a number of actions beyond 2019."


EUR 590 million have been engaged under EU development policy to promote better ocean governance with third partners.

Over EUR 500 million have been spent on marine research under the Horizon 2020 research and innovation programme.

The agenda has strengthened the EU's role as:

- a reliable partner in building an international governance framework with UNCLOS at its core
- a top donor to build capacity and spur local, regional and global action;
- a strong supporter and service provider for ocean research, monitoring and surveillance.
- a coherent 'blue' economy business partner with an inclusive and sustainable outlook.



Reactions on the report

- The EU is well recognized as ocean leader and for kick-starting the debate on ocean governance
- A cross-cutting approach to oceans is essential. Great strides have been made in the EU and globally in recent years, but we are not there yet;
- Also within the EP a more integrated approach is needed (Parliament Ocean committee?);
- EU Ocean Agency ?
