NAFO and NEAFC JDP



- Ensure the implementation of NAFO CEM and NEAFC Scheme by the MS and other CP which vessels are fishing in NAFO and NEAFC R.A.
- To ensure the presence of an EU inspection vessel in the NAFO and NEAFC R.A.
- To contribute to uniform and effective application of inspection and surveillance measures.
- Training and formation of EU national fisheries inspectors.



NAFO and NEAFC JDP



- In charge of NAFO campaigns since 2007
- NAFO first JDP in 2008
- NEAFC first JDP in 2009
- NAFO and NEAFC joint JDP from 2010
- Present NAFO and NEAFC JDP is applicable for 2015-2019



Definitions



Sea campaign – coordinated planning and implementation of joint control, inspection and surveillance activities in NAFO or NEAFC R.A. during a certain period of time marked, in principle, by a start and end date.

Union NAFO inspector - official assigned by a MS, the EFCA or the Commission to the NAFO Scheme and made available by that MS, the EFCA or the Commission for the purpose of carrying out sea inspections



Definitions



EFCA Coordinator - a coordinator who is appointed by the EFCA.

Joint inspection team – consists of a maximum of two Union NAFO or NEAFC inspectors to carry out inspections at sea.

Mixed team – a team of Union or national inspectors of the port MS who are in charge of a port inspection, with the presence of Union inspector from other participating MS.



Objectives of JDP



- Coordination, technical assistance and support to the Union NAFO and NEAFC inspectors in their duties.
- Control of compliance with NAFO CEM and NEAFC Scheme by vessels operating in the NAFO and NEAFC R.A., including non Union fishing vessels.
- Control of the reliability of catch reporting.



NAFO and NEAFC

Objectives for sea campaigns



Agreed in the Technical Joint Deployment Group (TJDG) meeting in the beginning of every year.

Overall objective:

To conduct inspections at sea in order to verify compliance by EU and other CP vessels fishing in the NAFO RA with requirements of NAFO CEM, and fishing in the NEAFC RA with requirements of the NEAFC Scheme and Recommendations, as well as compliance by EU fishing vessels with any other Union legislation



Training of inspectors



Annual training of EU NAFO inspectors in November-December every year

Annual training of EU NEAFC inspectors in February-March every year

Both organized by EFCA in close cooperation with the Commission

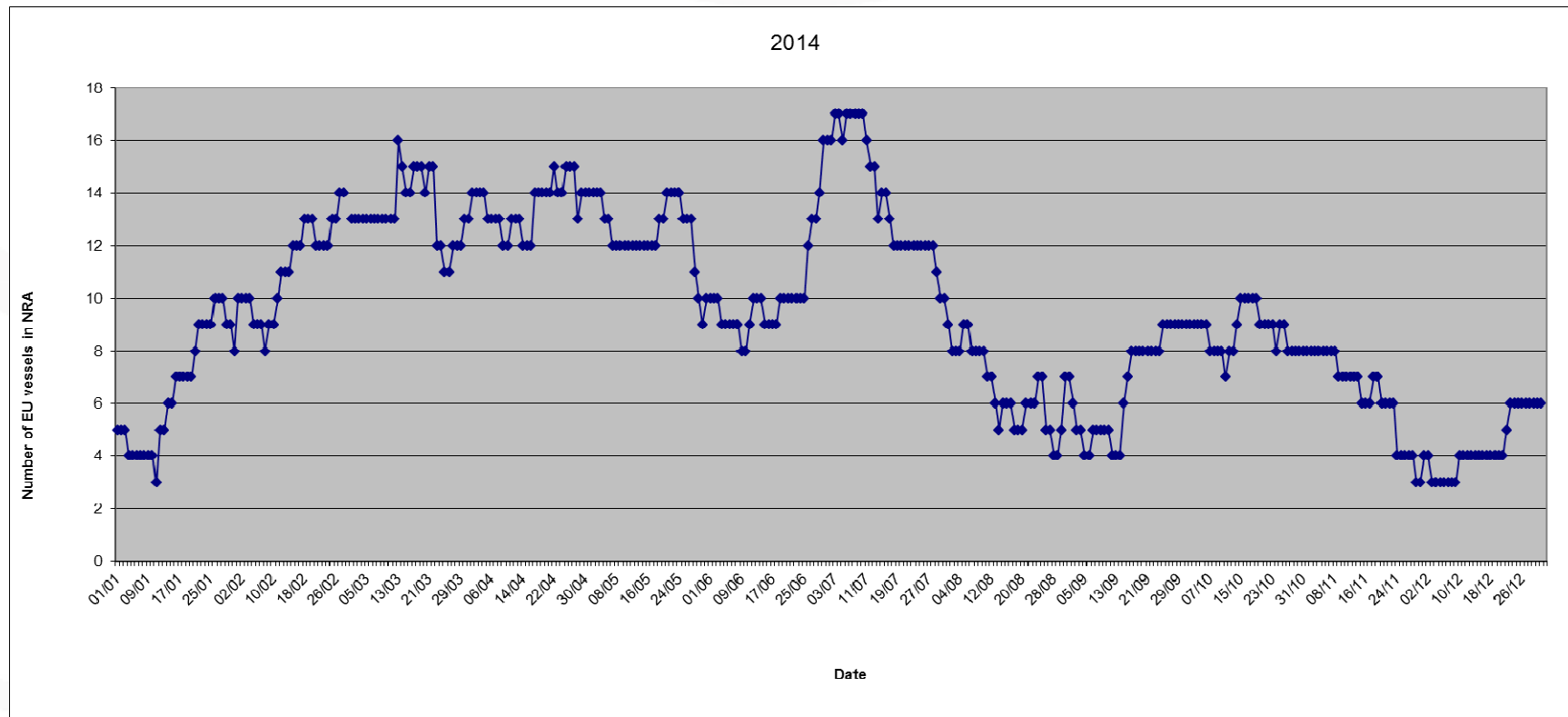


On board EU FPV in the NAFO RA:

- Cooperation with other CP (CAN) FPV present in area

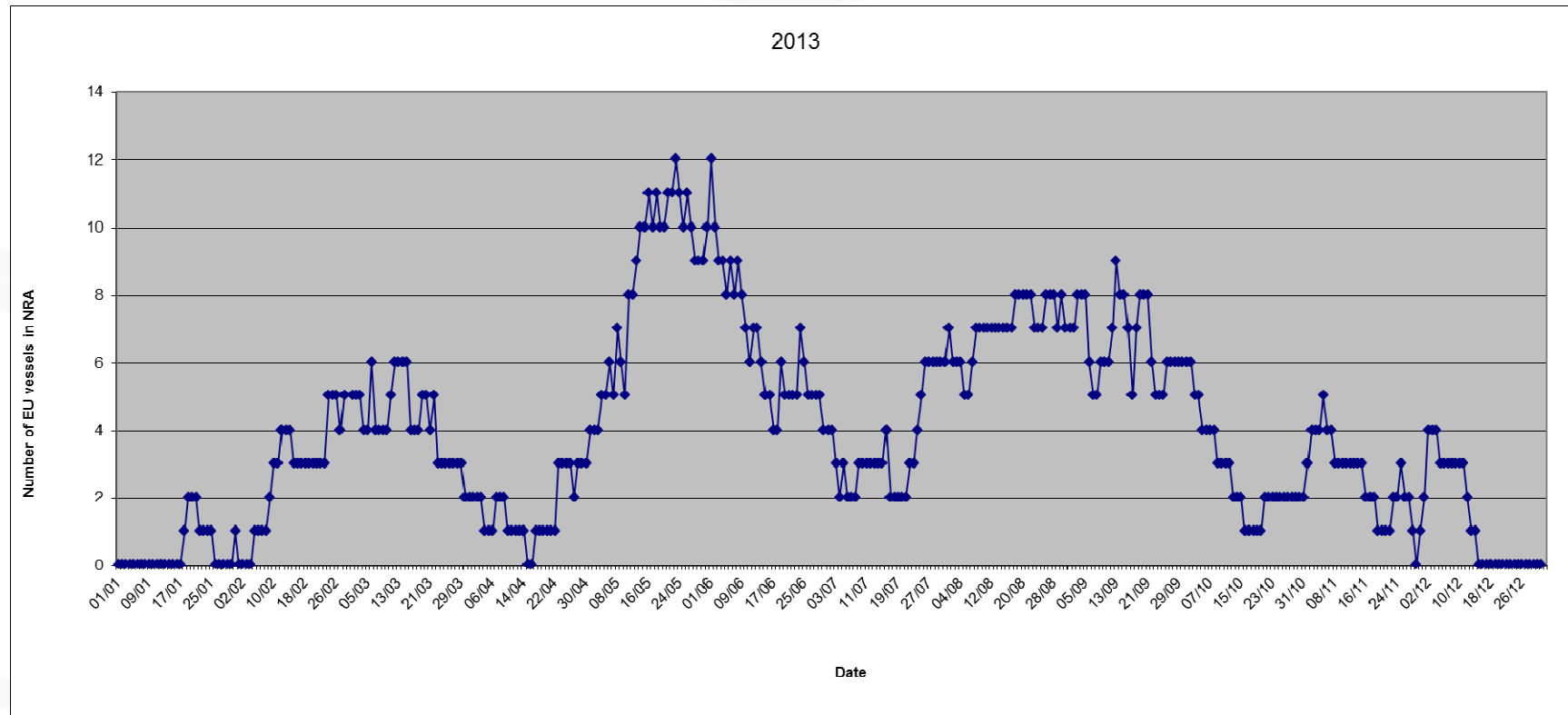


Fishing activity of MS during 2014 in NAFO RA
