

# RESUP Project Algeria



**Objective:** To support the development of capacities in Algeria for the control and monitoring of fishing activities.

#### The project focuses on:

- Equipping fishing vessels with VMS
- Training and strengthening the capacities of personnel responsible for implementation of these systems (FMC operators)
- Updating the legal framework in line with ICCAT and GFCM recommendations.



#### Main areas of intervention





Organisation of joint patrols

- Planning, implementation and evaluation of joint patrols
  - Regional and tactical risk assessment
  - EFCA to support exchanges of inspectors (WASOP)
- Presence at FMC
- "Hands-on" training (inspectors, FMC operators, legal officers)
- Control means:
  - Possible synergies with actors in the region





Support to the maritime picture awareness

- Satellite image analysis
- Facilitate exchange of fisheries data and intelligence
  - Promoting/developing standardized protocols for data exchange/information management;
  - Promoting exchange taking advantage of existing regional tools
- Presence in FMCs



Information sharing processes





Support to regional and national development of MCS:

- Support implementation of national strategies to reinforce MCS capacity
- Assist in aligning legislation and action plans with international and RFMO obligations.





Provision of training

- Training for trainers, Fisheries Monitoring Centres operators, fisheries inspectors, judicial personnel, and officials in charge of the validation of EU catch certificates;
- Training on risk assessment;
- Training to be delivered on
  - Key areas identified by joint risk assessment
  - Key areas identified by DG MARE
  - Specific requests by 3rd countries
