3.3. Transparency: Ensuring Fair Competition and Accountability

- *Do you consider that compliance with flag, coastal, port and market State responsibilities remains the foundation for a global level playing field? Which additional elements should be taken into account?*
- *Do you agree that enhancing transparency obligations is key to ensuring compliance and fairness in global fisheries?*
- *Are flags of convenience, IUU fishing, transshipment on the high seas, and insufficient implementation of the FAO Port State Measures Agreement (PSMA) the main issues of concern, or would you identify others?*
- *Would promoting international uptake of EU control rules and new monitoring technologies be effective levers for greater transparency?*
- *How can the EU best address two key drivers of unfair competition:*
 - (a) capacity-enhancing public subsidies, and*
 - (b) lack of transparency on the ultimate beneficial ownership of vessels and companies?*
- *What mechanisms could the EU use to trigger international cooperation in these areas, and which fora (e.g. FAO, WTO, OECD, RFMOs, UN) would be most relevant?*
- *Suitability of incorporating fishing joint ventures into the external dimension of the Common Fisheries Policy.*
