1. Welcome from the Chair and authorities.

The Executive Secretary informs the members that in accordance with the LDAC rules of procedure, the required quorum for decisions has been fulfilled, as at least 50% of total members are present or represented by proxy.

2. Reading and approval of the agenda.

The agenda is approved with no changes.

3. Reading and approval of the minutes of the previous meeting (Rome, 10 May 2018)

The minutes of the previous General Assembly held in Rome on 10 May 2018 are approved, with neither comments nor modifications.



4. Report by the Chair/Secretariat on Financial Year 13 (1 June 2019 – 31 May 2020)

4.1. Strategy Plan/Annual Work Programme.

The Secretary General, Mr Alexandre Rodríguez, explains the Strategy Plan along with the Annual Work programme for LDAC Financial Year 13.

DECISION:

The members of the General Assembly approve the Strategy Plan of LDAC Financial Year 13. It is explained that the Work Programme only reflects those meetings organised by the LDAC. With the approval, the General Assembly concludes the process and the Strategy Plan is deemed formally adopted pursuant to the provisions of articles 13 and 15 section a) of the LDAC's statutory rules.

4.2. Provisional timeline and calendar of meetings.

The Secretary General, Mr Alexandre Rodríguez, informs that the meetings of next working groups 1, 4 and 5 will be held in October in Brussels and that working group 2 will probably meet in November, coinciding with the annual NEAFC meeting.

It is also announced that the next Executive Committee meeting will be held in November 2019 in Madrid. The full calendar of meetings is provided for all members in the specific presentation: https://ldac.eu/images/LDAC presentation GA Sopot 22.05.19.pdf

The Chair, Mr Iván López, takes the floor and explains the current structure of the working groups, presenting a new proposal that consists of:

- Including under WG2 remit those topics related to other RFMOs and management measures in the South West Atlantic previously deal with by WG3;
- Increasing the number of Executive Committee meetings to include strategic issues concerning the high seas, international law and the EU's role in international governance of the oceans.

After debate, the following **ACTIONS** are agreed:

- Ms Béatrice Gorez, CFFA-CAPE, suggests requesting the calendar of meetings from the EC for the forthcoming rounds of negotiations as well as the minutes of meetings of the joint and scientific committees of the Fisheries Partnership Agreements (SFPAs);
- Mr Iván López, Chair, will send a written proposal on reform or modification of the structure and content of the LDAC working groups. A specific point will be included in the agenda of the next Executive Committee meeting in November 2019.

5. Report by the Secretariat on administration and finances:

The Secretary General, Mr Alexandre Rodríguez, presented on behalf of the Chair and of the Executive Committee, an assessment of the work done by the organisation during LDAC Financial Year 12 (1 June 2018 to 31 May 2019), summarising the actions and agreements from the main meetings and listing the letters, recommendations and opinions adopted. There were no additional comments from the members.

5.1. State of the annual accounts (income/expenditure) of Financial Year 12 (2018-2019)

The Secretary General, Mr Alexandre Rodríguez, gives a detailed presentation of the breakdown of the accounts and the list of income received and spending by the LDAC, as well as the timeline and calendar of procedural actions pending of execution. The Secretary also reports that all the organisations, as well as the member-states, are up to date with their fees.

The European Commission has paid the first instalments of its contribution (240,000 euros). The remaining balance of up to a maximum of 60,000 euros will be effected once the final report of the year has been delivered and the accounts audited.

Once the current financial year's accounts have been presented, it is proposed that the General Assembly endorse with a vote of confidence the accounts as presented. The final adjustments and closing of accounts will be completed after the financial year ends (31 May 2019).

DECISION:

The annual report as well as the amendment to the annual accounts of LDAC Financial Year 12 are approved by consensus of the General Assembly members, with no objections, and the Secretariat is urged to complete the necessary formalities until the close of the financial year.

5.2. Proposed budget for Financial Year 13 (2019-2020)

The Secretary General, Mr Alexandre Rodríguez, informs that the new budget corresponding to Financial Year 13 will run from 1 June 2019 to 31 May 2020. The budget was sent to all the Executive Committee members for its adoption by email and to the GA members ahead of the meeting. The Secretariat is now waiting to receive the new contract from the European Commission so it can be signed soon.

After the presentation by the Secretary General of the provisional budget proposal approved by the Executive Committee, the Chair recommends that the General Assembly approve this provisional budget for the next financial year. He also indicates that the proposal presented is a budget of minimums based on the principle of budgetary caution, in compliance with the rules of the Commission's Financial Regulation, indicating as certain only income actually received and/or committed.

Similarly to previous financial years, a request for a formal amendment of the budget will be made to the Commission before the financial year ends to adjust the increase resulting from new income and to balance the expenditure items.

DECISION:

The members of the LDAC General Assembly approve by consensus the proposal for operating budget for LDAC Financial Year 13.



Regarding the proposed revision (increase) of salaries of the LDAC Secretariat personnel, based on a proposal of the Chair, the following **DECISION** was made, after debate:

- The General Assembly members unanimously approve the revision increasing the salary of the Secretariat personnel (Alexandre Rodríguez, Marta de Lucas and Manuela Iglesias). The General Assembly members task a committee formed by the Chair, Mr Iván López, the First Vice-Chair, Ms Béatrice Gorez, and the Second Vice-Chair, Mr Juan Manuel Liria, to decide the exact percentage individually for each employee, based on the available budget.

5.3. Overview of LDAC membership.

The Secretary General, Mr Alexandre Rodríguez, explains that no organisation applied to leave, and that there are currently 52 members. He next reports the membership applications from the following organisations:

In compliance with the new rules from the European Commission decision, each constituent group (60% fishing sector, 40% other interest groups) separately elected its own candidates by secret ballot vote.

The Secretariat was tasked with supervision of the process and the counting of votes so it could be communicated to the plenary General Assembly. The Secretariat acted as guarantor of legality following its role as arbitrator tasked with coordinating and supervising the process, to ensure respect for its impartiality and independence. After the secret ballot vote took place, the votes were counted and the General Assembly was informed of the results.

The results of the votes are attached as ANNEX II and ANNEX III of these minutes.

6.2. Vote and appointment of the Chair and Vice-Chairs.

The election of the Chair and the Vice-Chairs (2019-2022 period) was done by secret ballot vote, with the secretariat acting as guarantor of the process, counting the votes and informing the General Assembly of the following results:

- Chair of the LDAC Executive Committee: Mr Iván López;
- First Vice-Chair: Ms Béatrice Gorez;
- Second Vice-Chair: Mr Juan Manuel Liria Franch;
- Third Vice-Chair: Mr Marc Ghiglia.

7. Issues regarding the external dimension of the fisheries policy:

7.1. The EU's role in international ocean governance.

7.2. Report on progress of the UN High Seas Biodiversity Treaty (BBNJ)

The DG MARE representative, Mr Roderick Harte, gives a presentation by videoconference on international ocean governance, specifically about the BBNJ process.

The focus is mainly on three questions:

- Our position within the process;
- What is currently happening?
- Next steps.

He reports that four IGC negotiating rounds are planned, with a draft treaty that consists of a very long and complex document. He highlights that multiple proposals were suggested by the different delegations from the contracting parties. Regarding the EU's position, he highlights the proposal on capacity building, especially the importance of scientific resources, and of using clear tools with procedures for identification, administration and monitoring.

Regarding the meeting of the intergovernmental conference that will be held on 19-30 August in New York, he indicates that the negotiations can probably conclude in the first half of 2020. However, to reach a binding agreement more time will be needed for the negotiations.

Finally, he indicates that DG MARE is interested in learning the LDAC's position about aspects of the draft in so far as the negotiations on aspects such as the spatial management tools (ABMT) or the cumulative impacts of fishing activities on the ecosystem, among others, evolve.

9. Closure of the General Assembly.

The Chair, Mr Iván López, concludes the session, thanking the members and observers for their attendance and active participation, the interpreter team for their work during the meeting and the Secretariat for all the work on logistics, organisation and content as well as for preparation of this meeting.

Regarding the holding of the next General Assembly meeting, Mr Gerard van Balsfoort, DPTFA, offers his collaboration so that it can be held in May in the Netherlands.

The ordinary annual session of the General Assembly is declared closed.


