

Preliminary Findings – Institutional set-up

NAFO:

- Detailed and consensual advice in a good timing
- Almost no NGOs participating
- Rather easy negociating position for EU

ICCAT:

- Diverging positions: Tuna (FR/ES) Sharks (Industry/NGOs) and advice out of the timing
- A lots of NGOs participating
- Very complicated negociating position for EU

However LDAC is proposing common ground on observer coverage, principles of sound-based management, labour conditions, ... could also act as facilitator in the plenary.

Preliminary Findings – International policies streams

- Resource management (FAO)
- Labour condition (ILO)
- Trade (WTO)
- ➤ LDAC is at the cross-roads of these policies and with improved recognition in the cooperation framework at regional and international level (openness, modern, forward thinking, proactive, ...)
- ➤ LDAC could contribute to support EU in developing a level playing field at international level (Collaboration with MAC around EU "market power")

Preliminary Findings – Possible way of improvements

- Memorandum of Understanding with NAFO / ICCAT / IOTC ...? COFI ? UN ? As concrete work plans to be monitored by the RFMO's commission
- Side-events during plenary meetings as a way to raise profile of the LDAC, and identify contact persons
- Regional partnerships / dialogs (Africa, Latin America?, Indian Ocean?) in alignment with EU partnerships and cooperation practises
- Involvement in cooperation projects (PESCAO, FARFISH)
