



SUSTAINABLE DEVELOPMENT GOALS


To contribute to the fight against illegal, unreported and unregulated (IUU) fishing in the region.




Main areas of intervention



Organisation of joint patrols

- Planning, implementation and evaluation of joint patrols between EFCA and FCWC and SRFC
 - Regional and tactical risk assessment
 - EFCA to support exchanges of inspectors
- Presence at regional FMC
- “Hands-on” training (inspectors, FMC operators, legal officers)
- Control means:
 - Possible synergies with actors in the region

- Satellite image analysis
- Facilitate exchange of fisheries data and intelligence
 - Promoting/developing standardized protocols for data exchange/information management;
 - Promoting exchange taking advantage of existing regional tools
- Presence in FMCs

Support to regional and national development of MCS:

- Support implementation of national strategies to reinforce MCS capacity.
- Support the development of regional MCS protocols for migratory artisanal fisheries.
- Assist in aligning legislation and action plans with international and RFMO obligations.




Provision of training

- Training for trainers, Fisheries Monitoring Centres operators, fisheries inspectors, judicial personnel, and officials in charge of the validation of EU catch certificates;
- Training on risk assessment;
- Training to be delivered on
 - Key areas identified by joint risk assessment
 - Key areas identified by DG MARE - EC
 - Specific requests by non-EU countries

- **First practical training in the framework of WASOP Pilar 1**



The fisheries control and surveillance mechanisms in the region are consolidated, and the first phase of operationalization is launched in order to eliminate IUU fishing in Central Africa (in addition to the mechanisms provided for under fisheries agreements).
